Flotilla Commander (FC) Report:

- 1. Steve said that to date we've had no lens cleaning due to the drought in order to save water for the flush toilets.
- 2. Steve said that it was his intent to clean the glass of the lens at Pt. Cabrillo with water and alcohol. It was suggested that we do this on the day after Thanksgiving, Friday November 26th, as Madeleine has the day off from school. We need three people, two cleaning the glass (the brass will be cleaned later) and one on the third floor. Helen and Madeleine said they could come and Steve said he will contact Jen.
- 3. We have a visitor, a transfer from the flotilla in Tucson, AZ, and Leon mentioned that our two primary duties are cleaning the lenses at Pt. Cabrillo and Pt. Arena, and maintaining the fuel farm at Pt. Arena.
- 4. Glenn said that the Coast Guard and Cal Fire want to maintain the Pt. Arena fuel farm and the First Order Fresnel lens there. The Pt. Arena lens is maintained by volunteers under the leadership of one or more Auxiliarists. At this time the fuel farm is in limbo because Glenn is unable to complete the recirculation but the Coast Guard knows how to do the recirc. and complete the checklist. The Coast Guard is aware of the stand-down situation and that the recirc. takes half an hour to complete to ensure that the fuel meets military specifications. There was a SAR operation this week and Coast Guard were able to do the recirc. themselves. Helen or Glenn can do a visual inspection of the fuel farm to make sure that no vandalism or other damage has occurred. Helen and Glenn have asked to possibly do the recirc. on a day other than Monday.
